MINUTES

The meeting was called to order at 5:35 P.M. by the Chair, Mr. Greg Shafer.

1. WELCOME AND INTRODUCTION OF NEW PAC MEMBERS

Mr. Greg Shafer, PAC Chair, welcomed the new members to their first meeting of the Public Advisory Committee (PAC). Mr. Shafer also introduced the 2016 Vice Chairs: Ms. Angela Jones and Mr. Eric Norton. The Policy and Legislation Subcommittee Chair is Mr. Darin Hughes. Confirmation of the Public Involvement Subcommittee Chair is underway.

Mr. Shafer noted that the Baltimore Metropolitan Council (BMC) staffs the PAC, with the primary contact being Ms. Monica Haines Benkhedda. Tonight, Mr. Todd Lang, Director of Transportation Planning, attends as well.

Mr. Shafer invited members to introduce themselves and share a bit of their background.

2. OVERVIEW OF THE BALTIMORE REGIONAL TRANSPORTATION BOARD

Mr. Lang provided members with an overview of the BRTB and its responsibilities as a Metropolitan Planning Organization (MPO), as well as the typical work products it produces. Ms. Haines Benkhedda shared ways the PAC and other members of the public can be involved. She also noted that the PAC has a Google Group for PAC members to share information and collaborate on documents. She asked that each member contact her if they are unable to access this group. Lastly, she highlighted the various social media accounts that staff oversee for BMC/BRTB and asked that members connect with these accounts and share information with their own networks.

3. PAC AND OVERVIEW OF SUBCOMMITTEES

Mr. Shafer provided an overview of the PAC's mission and responsibilities as an advisory committee to the BRTB, as well as the subcommittee structure and decision-making process. He noted that a key role of the PAC is to serve as a conduit between the BRTB and the public (including coworkers,

community organizations, neighbors, etc.). He encouraged members to take a strong and active role in the committee by being proactive and to leverage member contacts to gather input from other members of the public and share this perspective with other members and in feedback to the PAC.

Mr. Shafer emphasized the importance of members communicating via Google Group, as well as staying connected to BMC/BRTB through social media in order to be aware of news and upcoming action items. He also encouraged new members to visit <u>baltometro.org</u> to become more familiar with the BRTB or to access recent BRTB/PAC minutes, presentations, etc.

- 3. Outstanding Issues from Maximize 2040
 - a. Increasing Bike/Ped Mode Share
 - b. Increasing Transit Ridership

Following the small group discussions, Mr. Shafer reported that he would type up the notes from the groups and email to the full group for further refinement and discussion. Members also asked for additional information about the certification process and transportation equity / environmental justice. Staff agreed to schedule speakers on these topics for future meetings.

The BRTB also received presentations on MTA's BaltimoreLINK transit proposal and <u>Fixing America's Surface Transportation (FAST) Act</u>, the new five-year Federal Surface Transportation Act.
