Background and Purpose

- This action is needed in order to amend the FY 2023 UPWP to carry over funding for tasks that were not completed in FY 2022, or earlier.
- For consultant or subarea tasks that were not completed, the remaining funds need to be moved to the FY 2023 UPWP in order for reimbursement to occur.
- Invoices are required to reflect activities in the current work program.
