10	If a pump is required, is the fee to be included in the bid differential pricing or a separate line item on the invoice?	All fees related to use of a pump shall be included in the quotation for bid ITEM 6. This pump surcharge is only applicable for transport deliveries.
11	What is the average delivery size for each product and mode of delivery?	The delivery size for Baltimore County Public Schools varies depending on tank size and rate of consumption. Both Transport and Tank Wagon delivery modes are utilized depending on the quantity of fuel oil requested. Typical delivery mode is identified on the chart provided with bid documents. Mode of delivery is the responsibility of the vendor. If an order is placed for 7200 gallons or above, then the agency shall be invoiced at the Transport Delivery rate.






